EXHIBIT A STATEMENT OF OBJECTIVE

Statement of Objective:

The purpose of this Statement of Objective is to provide landscaping services for Valley Regional Transit (VRT) facility located in Canyon County, Idaho.

Location of Service:

Valley Regional Transit (VRT), Happy Day Transit Center (HDTC) located at 5907 Cleveland Blvd, Caldwell, Idaho 83607

Requirements / Deliverables:

The Offeror shall furnish all management/supervision, labor, materials, tools, equipment, transportation, insurance, supplies, and other items necessary to perform the work described within the Statement of Objective and the terms and conditions of the contract.

Work to be performed:

- Offeror will coordinate with VRT's project manager in scheduling all work.
- Weekly lawn mowing, lawn trimming (edging), and weeding of all grass areas and gravel beds on the property and along the perimeter.
- Bagging is required when mowing.
- Removal of lawn clippings, trash, tree/shrub trimming and debris from work site.
- All waste materials (lawn clippings, trash, tree/shrub trimming and debris) will be removed and disposed of by the offeror in a proper manner that is compliant with federal, state, and local regulations.
- Sweeping and blowing of sidewalks, street curbs, gravel beds, employee parking, bus parking and pedestrian areas on site.
- Weekly trash pick-up around premises including landscape, and pedestrian areas.
- Weekly lawn trimming (edging) of landscape areas.
- · Bi-annual tree and shrub trimming.
- Bi-annual weed and fertilizer spraying or treatment (as needed).
- Spring and fall clean up and fertilizing.
- Sprinkler inspection and sprinkler repairs as needed.
- Sprinklers startup and blowout as needed for fall and spring.
- Other landscaping services to be determined if necessary.

Safety Plan:

Offeror agrees to perform all work outlined in the Statement of Objective in a safe matter.

Offeror will ensure all employees wear the appropriate personal protective equipment (PPE) for the activity they are performing that is compliant with OSHA's PPE standards.

Offeror will report any unsafe conditions to VRT's project manager.

Proposal to include the cost for a Spring and Fall cleanup of work area.

Spring cleanup to include:

Must be completed by May 1st.

Removal of any leaves left over from Fall

Cut back any winter growth on plants, shrubs and bushes

Supply and Spread 3" (minimum) of fresh dark mulch (as needed)

Edging of grass areas

Apply crabgrass, dandelion and other major weed inhibitors through the lawn, building perimeter, front and rear parking lot, and gravel beds.

Fall clean up to include:

Clear out fallen leaves, litter & debris from lawns, beds, curbs, front and rear parking lots and sidewalks

Trim shrubs and bushes

Trim any dead branches off trees that are within reach no special equipment required Add fall lawn fertilizer with high phosphorus content to encourage root growth.

Maintenance of Equipment:

Offeror shall be responsible for supplying all tools/equipment and properly maintain the equipment in a proper state of repair to perform the duties of this contract.

Chemicals:

Offeror may use lawn fertilizer that is compliant with Federal, State and local laws and regulations.

Pesticides used in this contract shall not carry any State or Federal restrictions.

Any products that leave an undesirable residue or odor shall not be used.

Offeror will comply with all federal, state, and local regulations in the handling, application, disposal, and storage of all chemicals and/or hazardous chemicals.

Offeror will supply all necessary data sheets and meet requirements to comply with the Federal/State OSHA Regulations.

Offeror Performance and behavior:

Offeror shall perform all work under this contract in a professional, polite, respectful and cooperative manner, minimizing the noise and any interruption of VRT services.

General good behavior is expected of employees and persons on site at all times. loud music, excessive wasted time on site, time spent chatting with security or others should be avoided. Profanity, crude language or inappropriate behavior by employees to each other or to VRT staff, the public or security is not allowed.

Neglect, Vandalism and Property Damage:
