

VRT LATE NIGHT ASSISTANCE- TRANSPORTATION FOR LOW-INCOME EMPLOYEES

This program is for low-income workers who need transportation solutions to and from work outside of regular bus service hours. The fare is a minimum of \$3 per trip. VRT will pay up to \$20 of the additional ride costs, but the participant is responsible for any amount above \$23 in addition to the \$3 fare.

VRT LATE NIGHT QUALIFICATION REQUIREMENTS

In order to access this low-income transportation service, individuals must first meet eligibility requirements. Human Service Agencies can assist individuals with this application or individuals may apply themselves:

- 🗸 🗸 Provide a pay stub from the last 30 days or a letter from your employer that states you are employed.
 - ✓ Demonstrate that your household earnings meet the most recent Poverty Guidelines as indicated below, or provide documentation (with your name on it) from a Health & Welfare program showing that you receive benefits (Medicare/Medicaid, Food Stamps SNAP, etc.).
- ✓ Home-to-work and/or work-to-home trips must be within the VRT Late Night Zone and the hours of operation.



HOW TO USE:

- 2. "VRT Late Night Ride from Valley Regional Transit" notification will be sent within the Lyft app.
- 3. Schedule your trip. Make sure both start and finish points are both within the Late Night Zone by using either the VRT Website or the Lyft App.
- 4. Take a ride: Become a regular Night Rider!

VRT LATE NIGHT PASSENGER AGREEMENT

The following rules are designed to promote the cooperation necessary for ride sharing. The operator and rider agree to honor these rules in good faith.

- 1. A reasonable effort will be made by the program operator to provide seven (7) day notice of substantial changes to VRT Late Night.
- 2. Passengers will meet their driver at the agreed upon location decided via App or when booking with VRT.
- 3. Riders will not share their Lyft code or VRT Late Night rides with other individuals.
- 4. Riders can cancel their rides with an hour or more notice without penalty.
- 5. Riders will not cancel their rides without an hour or more notice more than twice in one month or they may be suspended from the service.
- 6. Passengers are required to conduct themselves in a manner which promotes positive interaction with other riders and the driver.
- 7. Passengers shall help maintain the cleanliness and appearance of the vehicle.
- 8. The use of food and beverage aboard the vehicle is prohibited.
- 9. The driver and passenger agree that the use or possession or transportation of any alcoholic beverage or any narcotic drug, chemical or other substance in violation of the law is prohibited in the vehicle.
- 10. Driver and passenger agree that the use, possession or transportation of any firearms or weapons is prohibited.
- 11. No smoking is allowed in vehicles at any time.
- 12. Passengers agree to inform VRT if their schedule changes or the days/shifts they plan to use the service changes.
- 13. VRT Late Night will not operate on the following Holidays: Memorial Day, Independence Day, Labor Day, Thanksgiving, Christmas, and New Year's Day, unless prior agreement is made.
- 14. Riders will comply with the operator's terms and conditions or risk losing access to the program.
- 15. VRT Late Night is a pilot program and will be available as long as funding is available.

Yes, I understand and accept the conditions and rules of this agreement and may terminate this agreement by giving seven (7) days written notice.
